Open Enrollment

October 15, 2020 - November 16, 2020 is the State of Illinois Group Insurance open enrollment period. If you have had no changes in your current status, you don't need to do anything and you will automatically stay within your present plan. Should you and your spouse both be newly Medicare eligible, you must enroll into a Medicare Advantage Plan by November 16, 2020. You will continue to pay your federal Medicare premiums. To check on your current coverage status and whether you are required to make any benefit elections before the deadline, MyBenefits representatives are available Monday - Friday (8:00 a.m.- 6:00 p.m.), or online at: www.mybenefits.illinois.gov. All insurance changes become effective January 1, 2021.

A common telephone query to our office is whether a retiree can have an additional prescription plan and keep the State prescription plan. "If you choose to enroll in a different Medicare prescription drug plan not offered by your State of IL plan sponsor, you will lose coverage in your State plan and could also lose coverage for other insurance benefits you have through your plan sponsor."

Discount coupons (such as GoodRx) may be used if it proves less costly than using your State of IL prescription drug coverage. Keep in mind that if you use the discount coupons instead of your state prescription plan, any out of pocket cost would not be applied to your annual prescription deductible.
